Hillside Haven Safe House—A safe house is in the process of being set-up in rural Eddy County and the organizers requested a meeting with council members. Bruce made a motion to approve their request to make a presentation to the council, Jon seconded the motion, the motion carried.

Evaluation Committee Report—The committee reported that all evaluations went well and advised that Pastor Amy receive the average raise set by the synod for her years of experience which equals a 4% raise. They suggested that Katie also receive a 4% raise and Joan receive a \$25 per month raise.

NEW BUSINESS—

Extra Benevolence—Rick made a motion to give \$100 to the Chamber of Commerce to help with expenses for Santa Days, Jon seconded the motion, the motion carried.

Budget—Rick made a motion to accept the budget as presented with the recommendations of the evaluation committee for salary and benefits increases. Colleen seconded the motion, the motion carried.

Parsonage Allowance—The parsonage allowance for 2025 for Pastor Amy to utilize on her taxes was discussed. Colleen made a motion to set the allowance at \$1,500, Fern seconded the motion, the motion carried. The parsonage allowance is for tax reporting purposes only—there is no payment from First Lutheran Church involved.

The next regular board and council meetings will be held on January 8, 2025. The meeting was closed with steps 4 & 5 of the FAITH5, praying the Lord's Prayer, praying for special concerns of congregation and community members, and blessing one another with the sign of the cross. The meeting was adjourned at 8:40 p.m.

MONTHLY PASTOR'S REPORT—

Ministry and Community Activities—Pastor Amy continues her work with the synod Constitution Review Team, synod Lay Ministry Group Mentor, and as board member of Red Willow Bible Camp. She attended the RWBC annual meeting with our church's two delgates.

BOARD OF EDUCATION— BOE members reported that the LAUNCH Christmas Program will be held during the church service followed by a potluck on December 15. The next Metigoshe in Motion activity will be held on January 3. It will be a family night for children in Pre-K to Grade 5 from 6 pm-8 pm with a Lock-in for children in Grades 3-5 from 8:30 pm-10 am.

LAY MINISTRY/EVANGELISM—The Board Members are working on Christmas cards for shut-ins and Christmas gifts for selected volunteers.

PROPERTY/STEWARDSHIP BOARD—Board members presented a list of repairs that will need to be completed at the church and the parsonage in the next few years. This list was compiled to help set the fundraising goal for the Capital Campaign.

DECEMBER 2024 CHURCH COUNCIL MINUTES (UNAPPROVED BY COUNCIL)

First Lutheran Church Council members met in the fellowship hall at 7:25 on December 11, 2024. Council and board members in attendance were Pastor Amy Kippen, President Bruce Hirchert, Vice President Colleen Semmens, Treasurer Jon Johnson, Office Administrator Katie Jorgensen, Secretary Janel Fortney, Board of Education members Kayla Schumacher and LaShane Wobbema, Stewardship/Property members Corey Longnecker and Rick Swenson, and Evangelism/Lay Ministry member Fern Schuster. A quorum was met for the meeting.

The meeting was called to order by President Hirchert and the agenda was presented. Fern made a motion to approve the agenda, LaShane seconded the motion, the agenda was approved. Pastor Amy led steps 1-3 of **FAITH5**—1. SHARE highs and lows, 2. READ a Bible passage, 3. TALK about the passage.

SECRETARY'S REPORT—Pastor Amy made a motion to accept the minutes as written, Jon seconded the motion, the motion carried.

FINANCIAL & TREASURER'S REPORT—As of December 11, 2024, with the middle of the month bills paid, the checking account showed a balance of \$20,524.06. Colleen made a motion to receive the financial report, LaShane seconded the motion, the motion carried.
